3. We guarantee that all goods collected are processed and recycled according to National Legislation and that KM Ewaste is accredited by EWASA
4. KM E-waste will do an E-waste audit of the items collected if required from the client on site and serial numbers of items will be recorded.
5. All recycling certificate and reports required will be issued within 7 working days after collection.
6. KM E-waste will ensure collection required will be dealt with in accordance with The National Environmental Management Act (Act 107 of 1998) (NEMA) and The Occupational Health and Safety Act (Act 85 of 1993) (OHSA)
7. We will be bound by our confidentiality obligation, towards our client's needs.
